REASONED ORDER

Sub: Diversion of 10.617 ha. forest land under Chandaka Wildlife Division for construction of 200 feet Master Plan road over a length of 1.930 Km. from Utkal Health Care Hospital to Rail Vihar within Left Side Road Network (LSRN) (Modified CDP -02/2017) in Bhubaneswar City coming under Bhubaneswar Tahasil of Khordha District, Odisha by Executive Engineer, Bhubaneswar (R & B) Division No. III, Bhubaneswar.

Whereas, Forest Diversion Proposal bearing **Proposal No. FP/OR/ROAD/ 31840 /2018**, **State St. No.OR-016/2018 dated 22.03.2018** for diversion of 10.501 ha. of forest land as per DGPS Survey out of applied area 10.617 ha. under Chandaka Wildlife Division, Bhubaneswar for construction of 200 feet wide Master Plan Road over a length of 1.930 Km. from Utkal Health Care Hospital to Rail Vihar within Left Side Road Network (LSRN) (Modified CDP -02/2017) in Bhubaneswar city coming under Bhubaneswar Tahasil of Khordha District, Odisha was submitted by the Project proponent i.e. Executive Engineer, Bhubaneswar (R & B) Division No. III, Bhubaneswar and the said proposal was processed under the Forest (Conservation) Amendment Rule, 2003.

And whereas, the said diversion proposal over 10.617 ha. of forest land involves Reserved Forest Land – 9.197 ha. and Revenue Forest Land – 1.420 ha. under Chandaka Wildlife Division, Bhubaneswar.

And whereas, the aforesaid diversion proposal submitted over 10.617ha. has been accorded 'Stage- I/in-principle' approval under Sec - 2(ii) of the Forest (Conservation) Act,1980 by the Ministry of Environment, Forest and Climate Change, Government of India vide their Letter No. 5-ORC350/2018-BHU dtd. 18.07.2018.





And whereas, the guideline vide letter No.II-306/ 2014-FC of MoEF&CC, Govt. of India dated 07.05.2015 on simplified procedure for grant of permission for felling of trees standing on forest land to be diverted for execution of linear projects depicts the procedure to be followed to that effect and the State Govt. vide letter No. 10F(Con)92/2015(pt.)-11624/F&E dated 04.07.2015 has inter alia authorized the Divisional Forest Officer, (T & WL) to accord permission for tree cutting from forest land and allow commencement of work on forest land proposed for diversion for linear projects after compliance to conditions stipulated in Para 3(i) of Government of India guidelines dated 07.05.2015.

And whereas, the guideline vide letter No. 11-306/2014-FC(Pt) of MoEF & CC, Government of India dated 28.08.2015 on simplified procedure for grant of permission for felling of trees standing on forest land to be diverted for execution of linear projects states inter alia that the order for tree cutting and commencement of work of a linear project in forest land shall be for a period of one year i.e. from date of issue of this order.



Now therefore, the Project Proponent i.e. Executive Engineer, BBSR (R&B) Division No. III, Bhubaneswar is hereby allowed for tree cutting as per procedure laid by relevant Rules to the bare minimum out of total enumerated trees i.e. **2734** nos. of trees under the strict supervision of Forest Department and commencement of work in the forest land over **10.617** ha. under Chandaka Wildlife Division subject to strict compliance of the order of the Hon'ble National Green Tribunal vide order dated 13.03.2015 in O.A No. 52 of 2015 before commencement of tree felling in forest land as summarized hereunder-

- The project proponent shall publish the entire forest clearance granted in verbatim along with conditions and safeguards imposed by the Central Govt. in Stage-I forest clearance in two widely circulated daily Newspapers, one in vernacular language and the other in English language so as to make people aware of the permission granted to the project for use of forest land for non-forestry purposes.
- ii. The project proponent shall submit the copies of forest clearance orders granted by the Central Government / State Government to the heads of local bodies, Panchayats and Municipal bodies along with relevant offices of State Government, who in turn shall display the same within 30 days from the date of receipt.
- Detailed action taken in compliance to the above order shall be intimated to the Divisional Forest Officer, Chandaka Wildlife Division / Regional Chief Conservator of Forests, Bhubaneswar Circle, Bhubaneswar / Addl. Principal Chief Conservator of Forests (FD & NO, FC Act) Office of the Principal Chief Conservator of Forests & HoFF, Odisha, Bhubaneswar / Principal Chief Conservator of Forests (Wildlife) & Chief Wildlife Warden, Odisha, Bhubaneswar / Forest & Environment Department, Government of Odisha for reference before commencement of tree felling in respect of forest land involved in the project.

It is also pertinent to mention here that this order is subject to compliance of stipulated conditions of Stage-I approval of MoEF&CC, Govt. of India vide No. 5-ORC350/2018-BHU dtd. 18.07.2018 in respect of the aforesaid project proposal and non-compliance thereof within the deadline w.e.f. the date of issue-of this reasoned order i.e. 05.01.2019 as decided by the State Government vide letter No. 17194/F&E dated 28.09.2015 shall stand revoked on 04.01.2020.
